- b) Legislation David Tyahla There are rumors that Transportation Alternatives (TAP) may be hit hard. NRPA and others are responding.

Seems likely that there will be government shutdown on October 1 - not much movement on a budget.

LWCF - Congress has until the end of the month, but there has not been much progress. Most want to see LWCF reauthorized – but some want it reformed - this is a good sign. Energy bill has permanent reauthorization of LWCF. Includes a suite of stateside assistance programs. Does not include funding. NRPA recommends a larger percentage of funding to protect stateside funding.
