2) Secretary's Report – Kent Taylor

a) Mr. Taylor requested a motion to approve the October 31, 2022. Motion to approve by Mr. Schultz, seconded by Mr. Page. Motion approved by unanimous vote

3) Additions to the agenda

a) Board voted unanimously to send \$500 donation to a trail organization in memory of Steve Anderson a NACPRO Board member who passed away unexpectedly in November. The organization selected is the Sun Corridor Trail Alliance.

4) President's Report – Monique Odom

a) Ms. Odom presented the draft Executive Director contract for 2023-2027. Motion to approve by Ms. Rissler, seconded by Mr. Tully. Motion approved by unanimous vote.

5) Treasurer's Report – Nicole Rissler (attached)

a) Ms. Rissler presented the Treasurer's report. Motion to approve by Ms. Brown, seconded by Ms. Garcia. Motion passed by unanimous vote.

6) Executive Director's Report – Brenda Adams-Weyant

a) Ms. Adams-Weyant will bring the 2023 budget to the Board at its February meeting.

- b) Current membership count: 266 Professional, 3 Affiliate, 2 Retired, 1 sponsor. 40 new members since September 1.
- c) Ms. Adams-Weyant presented a sponsorship proposal from Mission Control. The Board discussed this opportunity and consensus was not to move forward with this type of sponsorship at this time.

7) Committee Reports/Business

- a) Social Justice Mr. Roszak presented an overview of the history of this Committee and an overview of possible next steps to be brought forward in the coming year. He also asked if any members are interested in assisting to please contact him or Ms. Adams-Weyant. Ms. Vosper suggested that we could pull together best practices and a create a toolbox. Ms. Garcia said they have issues with recruitment, suggested we could discuss at the annual meeting.
- **b)** Legislation Ms. Adams-Weyant suggested that Ms. Snyder get in touch with Mr. Vlaming for next steps, since NACo seems to be the most active part of the committee work. The committee would be meeting early in the new year.
- c) Awards Mr. Perry reported on the upcoming award schedule, nominations open January 6th and close on February 19th.
- **d)** Professional Education Ms. Vosper reported that there is an excellent education program being offered at the 2023 Special Park District Forum and encouraged everyone to register and sign up early.

8) Liaison/Affiliate reports

a) NACo - Jonathan Vlaming

Fall NACO Conference/meeting

I attended the Large Urban County Caucus (LUCC) /Board of Directors meetings in Oak Brook, Illinois in late November. LUCC is composed of 130 or so large counties that contain 160 million people (nearly half of the US population). A few things really hopped out for me:

- 1. Workforce Housing is at the forefront of urban county concerns. The term will likely replace "affordable housing". NACO just formed a task force on it.
 - 1. It got me thinking about the parks/housing interface and I started to dig into it a bit during downtimes. If your agency has landholdings in urban areas, you can expect to be pulled into this conversation. There may be pressure to convert open space to housing. There may be opportunities to integrate new open space with housing development. There may be debates over the pros and cons of urban park improvements, as some advocacy groups see park improvements as an inadvertent driver of gentrification and increased housing prices.
 - 2. It would be good to get ahead of this train and help steer discussion. <u>Is there interest at NACPRO in helping put together a panel of park directors who are dealing with parks/workforce housing integration to have a discussion session at the NACo summer meeting in Austin Texas?</u>
- 2. NACo (as explained by their CEO Matt Chase) is very proud of their fact-based approach to decision-making and advocacy. Unfortunately, on their site and in their published fact books, there is very little about parks. Here's a link to the online version of the fact book https://www.naco.org/about/counties-matter
 - 1. What are the benefits to expanding the awareness of and presence of parks within NACO publications?
 - 2. If so, what kind of info are they looking for?
 - 3. Can the study we put together to try to identify all of the park agencies/special districts/authorities/etc. be used to help provide solid data for NACO?

b) CAPRA – Jon Woodsby

Executive Committee (EC)
